Approval of September 11th meeting minutes Trustee Business: Judith moved the motion to approve, Joan seconded, all approved.

250th Committee - Time Capsule Request

Kathi described the time capsule project and asked if the library would participate by displaying the capsule for three weeks, finding a good location for its burial, possibly during the construction of the pocket park trail in the spring. The library would document its location and secure that information for 50 years, perhaps in the town vault. Hannah agreed to research how time capsules have been handled by other libraries. Discussion will be continued at the November board meeting.

Holiday something for Volunteers? Joan volunteered to arrange this, and Hannah will provide the number of staff and volunteers.

Beth Logan winter free concert? Beth Logan, a renowned jazz vocalist who drew a record audience at her Music on the Patio performance, has offered a free concert this winter. Date to be determined.

Kathi Lafferty offered two of the metal road signs marking this anniversary year as an auction item for a fundraiser to the Friends. Leslie will present the idea to the group.

Grounds Project

- Berkshire Design Group we have a signed contract. No Kick-off meeting scheduled yet.
- The engineering documents will be put out to bid in January or February.
- Conservation Commission 9/23/24 hearing

- They determined that our project would have minimal impact on the wetland,
 but that we need to have the boardwalk 6" above the high water line.
- The permit should be in hand soon.
- Con Com has a new agent and Hannah has received email responses.

Grants

- Submitted CPC grant application. 10/23/24 Meeting to review with CPC.
- Trustees expressed support for this strong grant proposal and thanked Leslie for the letter of support from the Friends.
- A strong Trustee and Friends turnout for the March open hearing review will be helpful.
- Cultural Council (preparing) for program funding for next year. They are due October 16
- The LCC sets aside 1/3 of their funding to support library programming.
- In response to her survey findings, Elena is planning programs that offer crafts.
 - Possible programs include Playful Mechanics with Jay Mankita, a bookbinding workshop, a quilling making workshop, a puppet show, and two historical crafting workshops.
 - A puppet show is planned for the kick-off of the summer reading program.
