1.) The Board reviewed the minutes from 1/3/06 and amended them. The Board will wait to approve the minutes until Dauchy provides the revised plan date for item #5 in those minutes.

- 2.) Received from LML Construction (Larry LaClaire, dba L & F Construction), check #12441 dated 1/9/2007, for \$100.00 for Installers Permit for 2007. Installer's **Permit** number **07-02** issued.
- 3.) Bruce Cohen (owner) @ **457 Long Plain Rd**. (map3, lot 35) and Bill Sieruta P.E., came in to present a permit application for the repair of a failed septic system. Assigned **DSCP R2007-01-17A.** Zipkowitz moves to conditionally approve the DSCP pending the plan review approval by Steve Ball, Health Agent. Fair seconds, all vote in approval. Permit fee paid by Sieruta with check #6899, dated 1/17/07, for \$300.00. Sieruta also paid \$150.00, as part of check #6900 for Cohen's soil evaluations that were done in Dec. '06.
- 4.) Fair reported on his discussion with a nurse practitioner about following-up on the confidential TB notices that the Board has been receiving. The Board will continue to monitor this situation.

- 7.) The Board reviewed the flyer drafted by Goscenski, for posting in town, announcing the upcoming Feb. 12 public informational meeting on regulating Outdoor Wood-burning Furnaces (OWB).
- 8.) The Board reviewed the letter to Sieruta in response to the variance request for Kevin Williams at **22 Richardson Road.** Zipkowitz signed and sent the letter dated January 17<sup>th</sup> stating that a variance was not required.
- 9.) Received Well Completion Report for Kevin Williams, **22 Richardson Road**, dated 1/4/07, drilled by Lynde Well Drilling, 265 feet deep, 25 gpm yield, static water level at 60 feet.
- 10.) Received from Quabbin Analytical Lab, Bacteriological Analysis Report for the **Village Coop** Public Water Supply, **180 Rattlesnake Gutter Road**, dated 1/11/07, indicating that the water sample tested was free of bacterial contamination.
- 11.) Received from ECS, Groundwater Monitoring Report for the **Leverett Sanitary Landfill**, Fall 2006, cover letter dated 1/10/2007.
