1. Received from Silas Ball \$100.00 (cash) for Installers Permit. Issued permit # 2011-6. Signed by **Zipkowitz**.
2. Clerk will send Permit to Abandoned Well at **13 Still Corner Road**, owner **Chris Shadoin**.
3. **Aaron Osborne**, present **Lead Mine Road Lot# 19, Map 7, Parcel 50**. Board received plans and DSCP application for new construction. Assigned **DSCP#C2011-05-16a**. Received letter from **Steve Ball, Health Agent** dated 5/11/2011 stating that the plan appears to meet requirements of the Title 5 and state environmental code and Leverett Local Regulations. Received from **Aaron Osborne** check #2084, dated 5/16/2011 for \$150.00 for Soil Evaluation. Received from **Aaron Osborne** check #2085, dated 5/16/2011 for \$300.00 for DSCP. Received from **Aaron Osborne** check#2086, dated 5/16/2011 for \$75.00 for well permit. **Fair** signed well permit. **Dauchy** moved to approve DSCP application for **Lead Mine Road, Map 7, Parcel 50**. Motion passed. Permit signed by **Dauchy** and issued to Osborne.

6. Received Title 5 Inspection report for **15 Two-Mile Road** with a conditional pass requiring D-Box replacement. The D-Box was replaced with **Steve Ball's** approval. **Zipkowitz** will check with **Ball** to see if a DSCP application and Certificate of Compliance are needed.
7. Received from **Evelyn Schuyler**, owner **95 Amherst Road** Application for Soil Evaluation dated 4/18/2011. Received from **Evelyn Schuyler** check# 2181, dated 5/6/2011 for \$150.00 for Soil Evaluation.
8. Received from **New England Central Railroad** notification of Vegetation Management beginning in June.
