FROM THE SELECT BOARD

Thanks!! To the LES 6th grade for the gourmet breakfast they provided at the town meeting and to the Leverett Historical Society for the delicious lunch! We're hoping that the 6th grade breakfast becomes a tradition so that we can start the day on a full stomach in the company of our friends and neighbors.

At the town meeting, a budget of \$5,148,863 was approved as was the purchase of a new police cruiser and a new fire engine. Stewart Olson gave us a power point presentation highlighting the many problems with the engine that is being replaced, not the least of which is driving it at night with the headlights going out.

Other highlights of the meeting included the amending of Sect. 4970 of the Zoning Bylaws to include a Solar Overlay District, the approval for the Select Board

to enter into an agreement with HCOG to provide electricity to residential customers in Leverett, and the approval for the Select Board to send the resolution brought forward by the Peace Committee to our state and federal representatives.

Although there was a unanimous vote to establish a municipal lighting plant in Leverett, this needed to be done by a ballot vote and is therefore not valid. We will hold the vote again at the next special town meeting. This vote is essential if Leverett wants to operate its own broadband system or join in a municipal cooperative such as Wired West.

This was Gary Gruber's last meeting as Moderator after many years of conducting town meetings with a sense of humor, fairness, and by the "book." Thanks again, Gary. Larry Farber will be filling his shoes.

The purchase of a new fire engine is contingent on a debt exclusion override vote on June 11th from 8 a.m. to 1 p.m. which is necessary for partial funding of the engine (the balance will come from stabilization funds). Please come and show your support for the safety of folks that drop everything to save our property and lives. The Fire Truck Committee has found an engine that is a good price, with many features that would improve their ability to fight fires of all types; a positive vote, followed by the sealed bid process is necessary to make the purchase.

Leverett is applying for a \$50,000 grant from MBI (Mass. Broadband Initiative) to fund a study of what it would take for Leverett, in conjunction with Crocker Communications, to provide the "last mile" of fiber optic cable to get everyone in town hooked up to high quality high-speed internet, television, and telephone service. In other news on this subject, MBI has extended the trunk line to come to the N. Leverett Fire Station. We are grateful to the folks at MBI for pushing ahead on this and seeing it through.

The Energy Committee and the Select Board are looking into putting a small solar farm at the Transfer Station. The details of such a plan will need to be worked out of course, but we are very excited at the possibility of taking this step toward energy self-sufficiency.

The Select Board and the Leverett School Committee are working on issues of equitable retiree benefits vis-à-vis Union 28 employees and town employees. Leverett, Shutesbury and Pelham are also looking at the feasibility of creating a School Union of the 3 towns which have so much in common. This would be a complicated process,

but the concept was well received by Rep. Steve Kulik and Sen. Stan Rosenberg at a meeting held on April 21st.

Leverett Scholarship Committee

The Leverett Scholarship Committee last met in April, 2010, to review the applications received from Amherst Regional High School class of 2010. After considering our criteria of connections to and residence in Leverett, financial need, academic performance, and community service, we were happy to select two recipients who shared the available scholarship with \$600 awarded to each. Melissa Rennie is attending Eastern University in Pennsylvania and is studying to become a nurse. Gordon Kaufman, who had attended both ARHS and Greenfield Community College's Early Transitional Program, entered the University of MA in Amherst this past January and is looking to Hospitality Management as his major. Both recipients have shown themselves to be hard workers and deserving of Leverett's support.

Melissa and Gordon are our tenth and eleventh recipients of the scholarship. The committee just met in May to consider a new group of applicants. LEVERETT HISTORICAL COMMISSION

Following the successful passing of the Historical Commission request for Community Preservation Committee funds at town meeting on April 30, the LHC is going forward with meeting the requirements of the Massachusetts Historical Commission to receive their funds so we can hire a preservation consultant.

That person will be decided on by July 30, we hope. Then the work begins to research and document East Leverett, Moore's Corner, and North Leverett. It will take about a year for the consultant to pull together and write all the necessary information to submit applications

write all the necessary information to submit applications to MHC and then the National Park Service so that these villages can achieve National Register Historic Districts. (Recognition only, no controls!) Residents of the three villages will be contacted about an informational meeting in the Fall. It took the Leverett Historical Commission five years of volunteer time to achieve that status for Leverett Center.

The LHC discussed two demolition delay reviews for two barns on Montague Road that collapsed under the heavy snow over the winter. Both were deemed beyond any repair and the demolition was allowed to proceed.

Community Preservation Committee

The Community Preservation Committee (CPC) has funds available for open space preservation, community

housing, historic preservation, or recreation. At the April 30, 2011, Town Meeting, voters appropriated funding for three projects from Community Preservation Act funds.

The first, from the Leverett Historical Commission, is for \$14,000 to procure the services of a professional consultant to research and prepare documents for National Register Historic Districts for North Leverett, Moore's Corner, and East Leverett, to join our Leverett Center Historic District. The Massachusetts Historical Commission has approved this project for a 50% (\$7000) reimbursement, contingent upon receipt of their own funding.

The second, from the Rattlesnake Gutter Trust, is for \$8,500 for purchase of an approximately one acre parcel of land on the shore of Leverett Pond off Cider Mill Road contiguous to other parcels recently acquired by the Town, and up to \$2,950 for fees associated with the purchase, for a total of \$11,450. This parcel will include the north end of the Friendship Trail. The south end of the trail is next to the pond inlet channel at the south end of Leverett Pond on Depot Road.

The third, from the Select Board, is for \$150,000 for the rehabilitation and continued preservation of the Leverett Town Hall, including removing and replacing the exterior siding and needed trim with wood, restoring the exterior as needed, painting the exterior, and repairing the interior buckled floor on the ground level.

The CPC has funds available and is seeking proposals for the next funding cycle. If you have a proposal for open space preservation, affordable housing, historic preservation, or recreation, please consider applying. Application forms are available from the Town Hall or may be downloaded from the Leverett Town Hall website at http://leverett.ma.us/. Look for the Community Preservation Application in the column on the left. Completed applications are due in Town Hall by December 1. We will meet with applicants in December to discuss proposals.

The next regular CPC meeting is at 7:30 on October 5, 2011 at Town Hall, when we will be glad to discuss proposals. We could meet sooner if the need arises. If you have an idea for a proposal and would like an exploratory meeting before that, or to be on the agenda for October 5, please email Laurel Kahn at LaurelKahn@aol.com. or call (413)548-9158.

Do you know what was happening in Leverett 100 years ago?

The Leverett Historical Society has a good idea of what was going on here in 1911 thanks to the diary entries of Israel Taylor, Leverett's Town Clerk from 1906-1926

The rest of the world learned that on May 26th the first Indianapolis 500 was held; on September 25th, a ground-breaking occurred for the building of Fenway Park; and on November 3rd, Cheverolet officially entered the automobile market in competition with the Ford Model T.

Meanwhile, here in Leverett, the Taylor family was living at what is now 101 Depot Rd., with a sizable farm. The daily activities included getting the horses shod, cleaning the water closet, pounding bones for the hens, paying \$2.00 for a doctor's house call; going to the railroad depot for a trip to Amherst or to get a load of grain, fertilizer, or supplies.

The diaries from which these entries came are now available at the Leverett Family Museum and will be on exhibit beginning July 2nd. Other parts of the exhibit will include pictures, items from the household, and of course, the diaries themselves. Anyone wishing to contribute should call Edie Field at 549-9452. The Museum is open on Saturdays from 10 AM-2 PM (extended hours) or by calling the above number. We welcome your visit.

Leverett Trails Committee (LTC)

Two new trails almost complete:

- (1) 4-H Forest we reopened the lower, loop trail along the west side of Doolittle Brook;
- (2) Woodard's Corner we created a new trail along the east side of Doolittle Brook connecting Shutesbury Road south to the Gordon King Life Estate (blueberry) property.

Most of the trail work was done on May 14th by 13 very hard-working folk ranging in age from 8 to 76, but other folks were out there ahead of time getting everything ready and are still out there finishing up. Do take some time this summer to enjoy these lovely trails.

While our summer plans are not finalized (we are waiting to hear about a DCR Grant to fund foot bridges and hiking trails connecting the eastern and western trails in the East Leverett area), both the committee members and the trail workers will keep in touch, work on trail projects, and plan a fall workday.

LTC is co-sponsored by the Leverett Conservation Commission and the Rattlesnake Gutter Trust. Special thanks to Tim Silva, an AmeriCorps/MassLIFT volunteer serving with the Kestrel Land Trust for his help in getting us off to a good start.

Please join us to celebrate the Town of Leverett's Friendship Trail

Sunday, June 19, 1-4 PM. The afternoon will begin at 1 PM at the Town Hall with a walk to 34 Long Hill Road by way of the Friendship Trail. There will be a short Rattlesnake Gutter Trust Annual Meeting followed by a raptor presentation and reception. Rain cancels the walk but not the meeting at 2:30 and the presentation.

The Friendship Trail was envisioned and so named by David Field when he and Mary donated land at the south end of the pond for conservation in 1992. In 2007 and 2011, the Community Preservation Committee and town meeting accepted RGT's proposals that the town purchase three additional properties along the trail using CPA funds.

The trail begins just down from the Town Hall and borders the pond's side up to Cider Mill Road providing view of the marshland and waterfowl, the church steeple, the length of the pond in its different moods, and the hills beyond. It affords a magnificent experience. Continuing on for five minutes the Long Hill Trail is reached with views of the town center and the valley to the south.

Our thanks to Philip and Catherine Woodard, Carlyle A. and Edith Field, and the late David and Mary Field for protecting this land for our community and to the residents of Leverett for supporting this effort.
