*Running for Office?

Elected officials with expiring terms who are running again as well as new candidates for office are asked to submit substantive statements to the *Newsletter* editor at townclerk@leverett.ma.us or leave in Town Clerk box at Town Hall, by 1 March 2012. Offices up for election

Assessors: One three-year term

Board of Health: Two three-year terms **Library Trustees:** Two three-year terms

Constable: One three-year term

Finance Committee: Two three-year terms
Assistant Moderator: One one-year term
Planning Board: Two five-year terms
School Committee: Two three-year terms
Select Board: One three-year term

Select Board: One three-year term **Tree Warden:** One one-year term

*If you are interested in running for office (and you are) please take a minute to read the short synopsis of each "job." You may find something that suits you.

Assessors: Includes three elected Assessors and one appointed half-time Administrative Assessor. The primary responsibility is to assure that property assessments are established and maintained in a fair and equitable manner in accordance with state mandates, and to process warrants for real estate, personal property, forestry, and vehicle excise taxes. The office of the Assessors is the only elected position in town that has state mandated qualifications that must be achieved within the first term of office. Qualified individuals can handle razzing about the high taxes in Leverett. Meetings: approximately twice per month.

Assistant Moderator: Performs the duties of the Moderator (running town meeting) in his/her absence.

Board of Health: Primary duties relate to the protection of public health, promotion of sanitary living conditions, control of disease, and protection of the environment. The Board of Health oversees soil evaluation and perc tests and approves disposal systems (for new construction, additions, and repairs or replacements of existing systems), applies well regulations. **Meetings:** two or more times per month.

Constable: Responsible for posting warrants for town meetings and elections. Is present during elections to ensure safety of polling place and ensure that the donut plate is out and coffee pot full.

Finance Committee: Oversees town spending. Works with Select Board prior to town meeting on budget issues. Runs the annual budget hearing. Approves (or not) expenditures from the reserve account. **Meetings:** Several per year, more during the months of January-March when the next fiscal year budget is being drafted.

Library Trustees: Responsible for overseeing the library. Establish policies and plans to provide services to the community, determine final budget, and conduct public relations. The trustees value individuals who are team players, have a sense of humor, and are avid readers. **Meetings:** once per month (except in July and August).

Planning Board: Write zoning and subdivision bylaws. Meet with individuals seeking to build or modify homes or divide land, and help decipher bylaws for the confused. The board is in the process of modifying the subdivision regulations as they relate to developments of 6 or fewer homes and make amendments to the conventional subdivision regulations. **Meetings:** once a month (except in summer).

Select Board: Official governing body of the town charged with setting policies and regulations which are not within the realm of town meeting. Makes appointments to ad hoc boards, committees, and commissions. Works directly with police, fire, and highway departments. Authorizes spending, calls town meetings, sets the warrant for Annual Town Meeting, develops town budget in cooperation with Finance Committee. ETC, ETC, ETC. Meetings: Second, fourth (and fifth if there is one) Tuesdays of the month.

SELECT BOARD

Leverett has been designated a Green Community by the state (thanks Margie and the Energy Committee!). We have been awarded funding of \$138,750 for use in reducing energy consumption by 20%. A lot of these reductions are already underway as a result of the ESCO project. Further reductions could come from lighting retrofitting not done through the ESCO project, hybrid vehicles for the public safety departments and possibly solar installations (solar installations don't technically "reduce" energy consumption).

The broadband project is progressing. G4S has been hired to draft and cost out a plan that will bring fiber optic cable to everyone's doorstep that will be capable of providing hi-speed internet access, television, and phone service. It is unclear at this point how the funding will work. Hopefully revenue will help cover a substantial cost of build-out loan payments and, after debts have been paid, the usage fees for the cable will provide ongoing revenue for the town. There will likely be a warrant article concerning this at the spring town meeting.

The Town Hall re-siding project is almost done and looks great. Painting on the front and north sides will be completed this spring. Kurtz Inc. has done a great job putting on the new siding, taking the time to deal with problems associated with re-siding an old building. This is a big improvement for the building and will add to its life. Thanks to everyone who supported the CPA funding for this project.

We are beginning the budget process for FY13. At this point the state does not plan to increase Chapter 70

funding for the school and it looks like a Proposition 2 ½ override would be required to cover the increased budget requests from the Leverett and Regional Schools. It had been hoped that both the Leverett School and the Amherst-Pelham Regional School would get some of the \$146,000,000 in additional Chapter 70 funding for Mass. schools but schools with declining enrollment are not getting an increase. As many additional school costs are a result of insufficiently funded mandated services and not from enrollment fluctuations, this doesn't seem just. I would encourage everyone who is concerned about this to write our representatives (Rep. Steve Kulik and Sen. Stan Rosenberg) and Governor Patrick.

The Regional School Study Committee (comprised of reps from Leverett, Shutesbury, Pelham, and Amherst) has applied for a grant from the state to fund consultants to do an in-depth study of regionalization options for these schools. The areas to be focused on are governance, finances, and education. We will find out in February if we have been awarded the grant. While there are no immediate plans to regionalize the Leverett School, we would like to have a professional view of what this could look like and what the costs would be.

The well committee has some new members and has been meeting to continue work on options to deal with private wells affected by the plume from the old landfill. We are grateful to everyone in town who takes the time to serve on the many committees and help brainstorm on often difficult problems.

Finally, it is with great sadness that we learned of the death of Fred Bixby, Leverett's former Chief of Police. Our sympathy goes out to his many friends and family.

From the Town Clerk

The annual Street List/Town Census was mailed in early January and many have been returned. It is not too late to return this form!! Returning the form keeps your family information up to date for school and emergency purposes and also keeps you active on the voting list. With the coming elections, it is important to have this information up to date. Several forms were returned to us by the Post Office stating that there was "no mail receptacle" at the street address. If you have not received a form, please call and let us know—another one will be sent out to you. Leave a message with your name and mailing address at 367-9220.

March 6 is the Presidential Primary in Massachusetts. Polls will be open that day from 7am until 8pm. Also on the ballot that day will be elections for State and Town Committee members. If you are registered in a political party you will be given the ballot for that party. If you are unenrolled in any party, you can choose between the Democratic, Republican and Green-Rainbow ballots on election day. February 15 is the last day to register to vote, or to change your political party designation for this upcoming election.

Town Hall will be open that day for special voter registration sessions from 2-4pm and from 7-8pm. You are also free to stop in the Town Hall at any time and pick up a mail-in registration form if the Town Clerk is not there. Some folks think that by changing or adding a political party on their Town Census form that this is sufficient—it is not. You must use official forms for registration and party changes.

Absentee ballots for the March 6 election are available. If you will be out of Leverett during voting hours on Election Day, you may request an absentee ballot in writing. Family members may request a ballot for someone who is out of town. Please include the name of the voter, address where registered, address where ballot is to be sent, and political party (if unenrolled, specify which ballot you would like). The request must be signed by the voter or family member.

From the Collector's Office:

2012 Motor Vehicle Excise Bills will be mailed within the next two weeks. Remember, it is the responsibility of the taxpayer to pay on time, regardless of when or if a bill is received!! If you own a motor vehicle and don't get an excise bill by February 28, call the collector's office. If you move, be sure to notify the registry of your new address so your bill can be delivered promptly. *PLEASE DO NOT IGNORE AN EXCISE BILL; if you don't think you owe it, contact the Assessors' office 548-4945.* Late payment can cost an additional \$71 in fees plus interest, and the bill must be paid in full before you can renew your license or registration.

Market value is NOT considered for the purpose of assessing motor vehicle excise tax. It is based on a five-year decreasing percentage (90%, 60%, 40%, 25%, 10%) of the *manufacturer's list price in the year of manufacture* and billed at a statewide rate of \$25 per \$1,000 of valuation. It is assessed for a *calendar year*; so if you don't own the vehicle for the entire year, file an application for abatement with the Assessors' Office. The excise will be adjusted accordingly or, if already paid, a refund issued. If abatement is not granted by the due date, pay the bill in full and, if applicable, a refund will be processed.

Pay online at the link on the Town's homepage leverett.ma.us. There is no charge for this service if paid from your checking account; but if you pay by credit/debit card (Mastercard, Discover, Visa) a fee is added based on the amount of payment. You can also sign up for direct pay, and your account will automatically be debited on the due date. If using your bank's bill-pay service, please enter bill# in the memo section. Mail payment to Collector, PO Box 300, or drop off at the Town Hall. If office is closed, please do not interrupt other town hall staff with questions regarding your tax; you can leave your check (or question) in the Collector's mailbox. Office is generally open

From the Real Estate Tax Relief Committee: Thanks to all of you who continue to contribute to the Real Estate Tax Relief Fund to help reduce the real estate tax bills of a number of deserving residents. We would like to encourage everyone to consider making a donation of \$1.00 or more when paying your next Excise and/or Real Estate Tax. You can simply add the amount to your payment or send a separate tax-deductible contribution anytime during the year to: Tax Relief Committee c/o Treasurer's Office, PO Box 300, Leverett MA. You can also request that your payment be applied to a specific bill. If you are 60 or older and having a difficult time making ends meet, call 548-9666 to request an application for tax relief.

Personal Property Tax

The Personal Property tax is a relict of the colonial era, when the number of goats, swine, and neat cattle (even the language is ancient) owned was a valid measure of a person's wealth. Today it is often a source of confusion and misunderstanding. However, the law is still on the books, and the Assessors are required to collect property data and bill for qualified property.

Determining what property is subject to the personal property tax can be confusing. The Massachusetts Department of Revenue defines Personal Property as "...goods, material objects and other things capable of ownership, which are not so firmly attached to, or specially designed for, real estate as to become part of the real estate"

However, there are numerous exemptions to the tax. The most significant are:

- Household furnishings and effects at the person's domicile;
- Wearing apparel;
- Motor vehicles, trailers and boats subject to the Excise Tax;
- Farming utensils (hand tools & relatively simple, inexpensive farm equipment);
- Tools of trade of a mechanic (plumber, carpenter, or other tradesman).

So what's left? Typical items Leverett taxpayers need to report are:

- Merchandise and stock in trade. Goods and wares for sale, whether in a store or any other place for sale, on consignment, or in storage or a warehouse.
- Business and professional office furnishings, fixtures and equipment. Computers and other office equipment if used in a business.
- Machinery, equipment and tools not exempted above. Includes stationary tools such as table saws, etc, heavy machinery, farm machinery and restaurant equipment.

- Medical and dental office equipment; professional libraries.
- Animals (Spot and Fluffy appear to be exempt, while Black Beauty, Bossy, Babe and just about any other creature that might reside in a barn, coop, pen or paddock are taxable). Noah would be in big trouble here.
- Unregistered motor vehicles & trailers (includes tractors, snowmobiles, golf carts and all other kinds and types of unregistered vehicles).
- Household furnishings not situated in the owner's primary residence, i.e. furnishings of summer/second homes. (Please file Form 2HF).

Personal property subject to taxation must be reported to the assessors on **State Tax Form 2**, known as the **Form of List.** Forms are mailed to taxpayers who have been subject to the tax in past years, or we believe might have taxable property. Any taxpayer who believes (s)he is subject to the tax and does not receive a Form 1 should contact the Assessors office for a copy.

NOTES FROM THE PLANNING BOARD

In response to requests from many citizens of the town the Planning Board has been working on updating our zoning bylaws regarding cell towers. We encouraged people to attend our regular November meeting to get a better sense of where folks are on this issue and to direct our efforts. Over 60 people attended and there was significant sentiment toward more cell towers in town, but with appropriate safeguards. The Board has devoted most of its attention over the past few months to this issue and we now have a draft of a new bylaw which relaxes our current zoning and, hopefully, invites interest in new cell tower construction. We're again looking for feedback and will hold an informal informational meeting on March 14 to review our ideas with all interested parties. This will be followed in April with a more formal public hearing of the updated proposal. It is our intention to present this new zoning bylaw to Spring Town Meeting. We invite all to attend the March 14 meeting and the public hearing now scheduled for April 11. The board meets regularly on the second Wednesday of each month and we welcome your ideas.

Leverett Dog Officer comments

It has been brought to my attention that there are some areas in town that have dog problems. One of the areas is the Lead Mine Road. I am writing this notice to explain the state laws governing dogs. Leverett does enforce these laws.

Leverett dog laws are as follows:

All dogs within the town of Leverett shall be restrained from running at large throughout the year, and shall be maintained and kept under control and supervision of the owner or keeper at all times (Code of Leverett, Chapter 78, Article 1). When you put your dog outside and stay inside you do not have control or supervision of your dog.

Someone walking on the town roads should not have to worry about your dog. Excessive barking is also a great annoyance and neighbors should not have to listen to it for prolonged periods of time.

If your dog bites a person or animal you are financially responsible.

If your dog is in the road and causes an accident, you are responsible.

If your dog kills livestock, you are responsible for the loss.

If you want a dog, take the time to be responsible. Stay with your dog when he/she is outside.

People being barked at or chased on roads should report it to me. Excessive barking should also be brought to my attention. I will take care of any complaint immediately. 549-1213

COMMUNITY PRESERVATION COMMITTEE

The Community Preservation Committee has funds available for open space preservation, affordable housing, historic preservation, or recreation. We have received the following **new applications** for funding in 2012:

1. From the Leverett Conservation Commission, Kestral Trust, and Rattlesnake Gutter Trust, an application for \$170,000 of Community Preservation funds to provide part of local matching funds toward a total project cost

of \$434,250 to purchase a Conservation Restriction (CR) on 147 acres of Teawaddle Hill Farm at 72 Teawaddle Hill Road. Leverett has been awarded a Massachusetts State LAND grant of \$237,600 for this project which requires local matching funds. Additional local fundraising of \$25,000, which is currently underway, is also necessary to meet the required local match amount. The CR will eliminate development rights on the farm in perpetuity for the purposes of protecting agricultural lands and natural resources, maintaining the property in its natural, scenic, and undeveloped condition, providing public access for recreation, and preventing uses or changes that interfere with these values.

- 2. From the North Leverett Cemetery Association, an application for \$29,950 to restore the metal fence on the street side of the Moores Corner Cemetery located on Rattlesnake Gutter Road near the Leverett Coop.
- 3. From the Leverett Cemetery Association, an application for \$28,000 to **restore 90+ stones in the North Cemetery** located on Montague Road about a mile north of Town Hall.
- 4. From Ted Goodnight and Katherine Theodore, an application for \$23,222 to restore the sills, beams, joists, and roof of the 1806 house at 21 Still Corner Road in East Leverett.

A copy of the complete text and backup materials for each of these proposals will be available at Town Hall by February 20 as will a draft of the 2012 CPA Report and Plan. Please stop by and take a look, and **plan to attend our public hearing on March 7**. We need to know what you think. Those projects recommended by the committee will be voted on at Annual Town Meeting in April.

Council on Aging News

The Leverett Council on Aging is the town body charged with doing the best we can for the seniors in town. As you can imagine, with the diversity in our small town, that charge is difficult to meet. We sponsor the Friday mealsite, and board members Judy Hobart and Sue Swartz oversee and volunteer weekly at the lunch. We also offer take-it-easy yoga for \$4 on Wednesdays at 10:00 at Town Hall, help arrange SHINE talks, and hopefully will help arrange for future flu clinics. We had hoped to help create a list for the town of seniors that would need support during an emergency like the one we had last Halloween but only one person responded. We try to be available as a resource. although navigating the world of resources for the elderly is quite an undertaking, especially when no-one can figure out exactly what the right questions are.

We receive a formula grant from the state of \$3500 which we have trouble spending on items that will benefit a large number of seniors in town and is also allowed under the grant. Last year, with our formula grant, we bought a Wii game. A newer TV was donated to the town and an unused TV stand was found at the school. It would be fun to get some bowling matches going—maybe with a few kids to help teach us how to play. Anyone interested in helping to implement this idea?

We also bought a **blood pressure monitor**. For quite a while, a nurse came to the mealsite once a month to take blood pressure and sometimes perform other services. The grant for that position ended and we had a volunteer for a while, but it did not work out. We would love to have a volunteer nurse come once a month to have lunch and stay a little while after on a Friday afternoon. We also could possibly pay for this service out of our formula grant. Liability is something we would need to figure out.

We have bought **a movie license** which allows us to show movies in public. However, we did not get great results when we offered some movies last year and we hate to go through the trouble of scheduling this kind of thing if no-one is interested. If you would like to take on running some movies at the library, please contact us.

We are also in need of new members. What could you offer?

<u>Circuit Breaker Tax Credit</u>. If you are over 65 and your property tax is over 10% of your income, you may be eligible for this credit. You will need to file a Massachusetts Form 1 tax return to claim the credit, which is worth \$980 for 2011.

Voters at the Special Town Meeting approved the temporary borrowing of funds contingent on funding from the state (\$237,600), the town (CPA \$170,000), and private sources (\$25,000).

December 22, 2011. The town received the state grant! (\$237,600 or 60% of the cost of acquisition and closing costs);

Late January 2012. Residents received a letter describing the project and asking for assistance in raising the \$25,000 needed from private contributions. (If you misplaced your letter, you can contribute anyway! Send your check to Kestrel Land Trust, P.O. Box 1016, Amherst, MA 01004.)

March 7, 2012. The Community Preservation Committee will hold a public hearing on this year's CPA proposals including \$170,000 for the Teawaddle Hill Conservation Restriction.

April 28, 2012. Town Meeting will vote on the CPA funding.

June 2012. Purchase of the Conservation Restriction Summer 2012. Reimbursement of funds to the Town Questions? Leverett Historical Commission

The work on the three new Historic Districts at North Leverett, Moore's Corner, and East Leverett continues. Our consultant, Bonnie Parsons, is concentrating on East Leverett at the moment. She will meet with John and Georgana Foster who accumulated so much information and wrote so many articles about the mills and people who lived in East Leverett during their fifty-plus years living at 21 Still Corner Road. Then on to the other two villages.

Did you see the article in the *Montague Reporter* telling about the treasures we have inside the Town Hall? Did you notice that the reporter said about the portrait of John Leverett, "no one in town hall seemed to know where it came from."

Well, now we do know that the oil portrait is a copy of an original 17th century painting at the Peabody Essex Museum in Salem, and, in 1983, it was brought to the attention of the Leverett Historical Society by Gordon Howard. A fund-raising effort was initiated by Louise Minks, Annette Gibavic, and Lois Feldman, with the portrait on view at the Harvest Festival. Along with a grant of \$100 from the Arts Council, enough money was raised to purchase the portrait. A dedication took place in March 1984 in which Perky Greely gave a talk on Governor John Leverett's life and Suzanne Flynt, curator of the Memorial Hall Museum in Deerfield, spoke about the portrait.

The General Court in Boston selected the name of Leverett for the new town in 1774 as we separated from Sunderland. The portrait hangs to the right of the Treasurer's office. Please visit the Town Hall and see it, the other collections of photographs and paintings, and the wonderful stage screen painted by Thurston Munson in the 1930s.

Hi Shutesbury and Leverett Friends –

I've been notified that mountain- bike and cross-country skiers and their organized groups are chain-sawing new trails on Cowls and other private land in Leverett and Shutesbury. When an abutting landowner of ours asked a chain sawing mountain biker to stop cutting trees on his land, he was told that it was "public land" so it was "OK." It would NOT be OK if it were public land, and it is not OK on private.

Cowls does not allow any trail-building on its land. We allow only the Porcupine Ridge Runners to maintain existing snowmobile trails. Trees are Cowls' crop and we do not want them cut down by recreationists who enjoy using our private property. In fact we are prepared to prosecute if our crops are destroyed or any of our forest resources are taken.

Interestingly, one condition of our CR is that while we do allow recreation on our woods roads, *no trails are allowed to be built <u>or maintained</u> on the Paul C. Jones Working Forest (except maintenance by F&W/Cowls, permission on each occasion by the snowmobile club's specific named representative).*

I don't know if you know the bikers and xcountry skiers and associations who cut trails on private land, or if you have a way of reaching all residents, but we would really appreciate your help getting the word out about this upsetting situation.





Broadband Committee News

Nearly 60% of all Leverett households responded to the MBI Grant Broadband Survey, making it a very useful source of information as we evaluate options for building a fiber-optic local network for telecommunications services. Here are two charts of results:





As I write this, **MBI has already begun installing "middle mile" fiber optic connection points in Leverett.** These will be the nodes where the local network connects to the world. A local fiber optic network means Leverett households will link to the global network at state-of-the-art bandwidth speeds.

The Committee is preparing a FAQ (frequently asked questions) about fiber optic networks—to send to all households in the near future. Stay tuned.
