#### FROM THE SELECT BOARD

With only one minor technical glitch our Annual Town Meeting commenced almost on time and ran smoothly on April 28 at the school gym. microphone did not interfere with the full-throated participation of many town residents and guest speakers. The Town Warrant included 33 articles, all of which passed unanimously or near-unanimously. budget, \$6,052,921, increases by 1.4% the 2018 budget, and does not include a special, single-year \$20,000 appropriation to fund the elementary school, also voted on and approved. With this appropriation included, the total budget for education in Leverett represents 66% of total projected 2019 spending. This appropriation was necessary due to a shortfall in the projected annual school revenue resulting from lower than anticipated school choice enrollment combined with lower grant revenue. This boosts property tax rate in Leverett from \$21.05 to an estimated \$21.41 for FY 2019, or \$3.58 below the Massachusetts Proposition 2 1/2 rate limit of \$25/\$1,000 assessed property tax. As the tax rate increases the town becomes increasingly vulnerable to unforeseen or unpredictable tax increases, (e.g., Leverett's contribution to the regional school district). Any major tax increase or combination of tax increases could result in a calculated rate above \$25/\$1,000 assessed property value, resulting in automatic state-imposed Proposition 2 1/2 spending limits AND spending reductions, until such time as Leverett can verify a tax rate below \$25/\$1,000. Examples of spending reductions include, but are not limited to, manpower reductions.

Other approved articles include costs associated with repair of the elementary school sprinkler system (\$88,521, in addition to \$27,950 approved last year), the purchase of a vehicle for the Fire Chief (a first for Leverett), purchase of an additional trash compactor for the Transfer Station, and various additional bookkeeping articles relating to town finances including transfer of funds from the budget and from free cash to fund the Capital Plan. Certain town building maintenance items were also voted on and approved.

Six articles were presented by the Conservation Preservation Committee to fund a variety of initiatives including hiring a Land Use Planner to prepare an Open Space and Recreation Plan, repair the roof on the Leverett Crafts and Arts building, restore the Chestnut Hill Cemetery, and complete a report of the Town Historical Assets.

Another article passed was acceptance of MGL Chapter 64N, Section 3 which imposes a 3% local tax on retail sales of marijuana in town. All of this tax would return to the Town as revenue. Shortly thereafter, the Select Board was approached by a developer expressing interest in building a commercial greenhouse for marijuana production at the corner of Cave Hill Road and Montague Road. The developer proposed building the greenhouse complex and then leasing space to growers. Following a presentation to the Select Board the developer was directed to the Zoning Board of Appeals to pursue rezoning the land in question which currently is not zoned for commercial use. The prospect of a commercial greenhouse on this parcel evoked a broad inquisitive reaction on the part of residents living near the proposed building site. Over 20 residents attended a subsequent Select Board meeting to express their concerns relating to potential environmental and light pollution as well as traffic management and site security. The developer has not contacted the ZBA as of this writing.

Finally, the town passed an article presented by a Petitioner to lead the global effort to prevent nuclear war.

In other news, Colonial Power, the company selected by our Energy Committee to serve as the town's Energy Aggregator continues to monitor the energy market for a combination of green energy suppliers that could be combined to provide energy to the town at a rate below that which is commercially available. That more economical combination has yet to occur but there is reason for optimism. Also under consideration is the possibility of working with other communities in the region who together with Leverett could create a purchasing collaborative, but this is still in very early stages of discussion.

Efforts to secure the post office in its current location have both failed and succeeded. It is not possible for the town to either purchase the property, or to accept it as a gift from a benefactor in exchange for a tax abatement or other financial incentive. However, the post office has renewed its contract with the current owner for another five years, one year prior to expiration of the current lease agreement and thus securing its location for the next 6 years. The property remains for sale by the owner with this profitable lease agreement in place.

### **Energy Committee**

June 2018, and we still don't have the green-and-cheaper electricity aggregation so many of us have looked forward to and worked so hard to achieve. It's not hopeless and it is no one's fault, but it is wicked disappointing. As you read in the Select Board commentary for this newsletter, it has to do with the rates the electricity providers (Eversource for us) announce and the availability of better-priced green sources. Since corporations are preoccupied with their own profits, they can and do influence policies not friendly to green energy. But your energy committee members continue to work, plan, and keep vigilant and hopeful. In the meantime there are other options.

One is simply to really and truly CONSERVE electricity. Each family and individual deciding to use less electricity in our everyday lives is by far the best and easiest way to be a conscientious resident of Planet Earth. It gets a little tiresome to keep reminding ourselves to turn out lights not being used, turning off (UNPLUGGING) devices that use phantom power (power use even when turned off)--computers, dvd players etc. It may be a nuisance but we have to do it anyway! (Stoves, toaster ovens, and washing machines can stay plugged in when not in use.) Another suggestion: consider using your car for not fewer than three reasons--except for emergencies and spectacular weather events etc. And this is the season to hang up a clothesline. Many of us find hanging out our clothes to be quite satisfying, even a little fun! Dryers are power gluttons.

Another is to watch for other green options from 3rd party suppliers. Some of these arrangements have integrity and actually work. The solar company Nexamp is one example. Just don't automatically trust any offer. Some are deceptive and some are hard to get out of. Feel free to call or email me (Portia 548-9737; <a href="mailto:pweiskel@post.harvard.edu">pweiskel@post.harvard.edu</a>) and one of the committee members will help you think through any of these plans.

You can also entertain and educate yourself by actually reading your own electric bill. Eversource, for example, helpfully provides a graph on each bill comparing your energy consumption in the current billing month with your energy consumption in the same month a year earlier. Keep track of your use. What makes for the differences? Challenge yourself. It's a very illuminating exercise and surprisingly easy to do and not boring.

Do you flush ticks etc down the toilet? All that pristine drinking water from Leverett wells to flush away a bug? Not very clever in a world with diminishing drinkable water supplies.

Consider mowing as little of your lawn as you can get \_\_\_\_several in Leverett owned by satisfied users. Not only are they good mowers, they are less annoyingly loud and one doesn't worry about spilling gas and oil on the grass. No noxious fumes, either. And the more green your electricity source for charging the battery, the more valuable for reducing CO2 emissions.

One other note about aggregation: among other things, our committee is working with other Franklin County communities on the possibility of forming a much larger aggregation--a move that would make us a more attractive customer for suppliers.

#### Leverett Historical Commission

Did you know there were 10 one-room school houses in Leverett before 1950? Sometimes there were as many as 46 students in grades 1-8 in one room with one teacher! In 1950 there were four active one-room school houses when Leverett residents voted a BIG decision to consolidate the schools and build the remarkable school we have today. (The construction at that time included four classrooms--two grades each for grades 1-8, a cafeteria to serve hot lunches, offices, storage closet, and a gymnasium!) Our LES sixth grade class with Mrs. Bull has been interviewing many historians who attended one-room school houses before 1950. Come to the library on June 10, 3-5 P.M. for a reception to find out what they learned. Sixth graders and historians will be there!

The One-Room School House display is ongoing in the Community Room at the Leverett Library through the month of June. Surely our town can boast of the emphasis that we have placed on education for our children throughout the years!

#### **CEMETERY CONSERVATION**

The Leverett Cemetery Association arranges for the maintenance on most of the cemetery properties (mowing, spring/fall clean-up, etc.), but they do not look after individual markers. Many gravestones have been conserved in recent years through your Community Preservation Act funds. It is fun to place a flower at the marker of a veteran from the Revolutionary War and/or his wife, for instance. Even raking and cleaning after the mowing has been

#### **HISTORICAL ASSETS SURVEY**

Prior to the Historic Assets Survey concluding, the Historical Commission applied to CPC for a consultant who would complete the first step toward a strategic plan using the data from the survey results. CPC made a recommendation at town meeting that the Historical Commission be given the money for a third party analysis of the survey and a list of next steps. After bidding it out to three suppliers, we selected one and she is working on a report now. The report is slated to be finished by the fall. Concurrently, we have convened a small group of interested parties to explore funding possibilities for our historic assets. If there is one thing that is clear from the survey, it is that most everyone would like to have a strategic plan for the town and most everyone would like our historic assets taken care of through a variety of funding vehicles.

#### SHRAB VETERANS RECOGNITION GRANT

Work with Martha Lyon, landscape architect, will begin on June 1 at a meeting with interested parties to determine the scope of work. The goal of her assessment will be to provide recommendations for preserving each of Leverett's 12 historic cemetery landscapes, with a focus on increased visitor access and opportunities for interpretation. Designing signs for each cemetery is also a goal of the grant.

# **Around Town**

#### LEVERETT CEMETERY ASSOCIATION

The Leverertt Cemetery Association held its annual meeting on May 9th.We feel that many of you are not well informed about Leverett cemeteries. So—here goes.

The usual reports were read. The information gathered by UMASS graduate students last summer was shown, these included summaries of the history of the cemeteries that are not included in the town's historic districts. They are Mt Toby, Long Plain/ Depot, (soon to have its name changed to Hillsboro), North, Plainview, and Wiley. We deeply appreciate their efforts.

The cemeteries are mowed twice before Memorial Day, twice in June, once in July, August, September and October. November sees a cleanup for each. There are two in North Leverett and four in Leverett. The total cost

(for all six) is \$640.00.Extra expenses include removing dead branches or entire trees, and these are additional costs. American flags are put on all the graves of Leverett military personnel each year. For more news about our cemeteries, see the article in this letter from the Leverett Historical Commission.

We also discussed green burials. There are a number of choices for this procedure. Plans need to be made ahead, as they differ from the usual burial plans. Please be aware of this if you are thinking in this direction.

Jackson Hill, our latest repaired and restored cemetery, is available for viewing. To park, pull off the road slightly, and trudge up a short slope, open the gate, and view the results of TaMara Conde's labors. We will keep doing our best to make these "outdoor museums" all look this beautiful. #### **NEWS FROM THE POND**

The Friends of Leverett Pond are proud to have contributed funds to our Fire Department for the purchase of needed equipment to draw water from the pond and other waterbodies throughout the town fill the tank on its fire truck. As a community-based group we feel an obligation to do what we can, especially during a time of tight budgets.

We continue to fundraise for our big effort to replace the old and failing dam at the north end of the pond. Built in the 1930s it is leaking and in need of replacement. We are sponsoring an <u>auction</u> on <u>June 16</u> at Leverett Crafts & Arts to raise \$\$ for this project. Many of the top artists in the Valley have signed up and will contribute their work to this event. Steve Adams will be auctioneer. This, by itself, is reason to attend. In addition there will be some surprise (non-art) items


