Candidate Statements:

Our library plays an essential and outsized role in town; it serves as a social, cultural, and educational center. I would like to continue working with its board, staff, and volunteers in keeping the Leverett Library a welcoming place for all.

My first year on the School Committee was a wonderful and rewarding learning experience and I would be honored to continue my service. I have lived in Leverett since 2011 and currently have two children at Leverett Elementary.

Craig Cohen, School Committee Select Board

We have survived another budget season in preparation for town meeting. The Capital Planning Committee has revised the list of equipment needs after joint meetings with department heads and the select board. This was a big job as the needs of the town has changed and the old list had become outdated. This does mean that over time we should increase our set asides for the stabilization fund to ensure that money is available as equipment comes up for replacement.

There will be some larger increases in the fire department budget to ensure the proper training of an expanded call force. The library will also have a larger increase to accommodate the financial requirements for participating in CWMARS. Other departments were able to keep increases at or below the maximum 2% increase requested by the finance committee and the select board. Thanks to everyone for the cooperative spirit that prevailed in these discussions.

The towns in the regional school district have reached another temporary formula for the FY18 regional school assessment: 10% based on the statutory method (the state default method) and 90% on the regional school agreement "5-year rolling-average method." The latest plan is to hire a consultant to help us come up with a permanent method that takes into account "ability to pay" based on a variety of criteria including (but not necessarily limited to) town financial information, low-tomoderate income averages as determined by HUD through census data and the state formula for determining a town's wealth.

The state Appellate Tax Board (ATB) finally handed down a decision, the large tax abatement case; it could have been better and it could have been much worse! We have to abate \$67,642 for FY 2014 and \$68,859 for FY 2015 plus a similar amount for 2017. The funds set aside should cover this amount. Going forward, that difference will be covered by increases to other tax payers, or a reduction in the budget. The ATB did come in with a much higher assessment than the property owners had sought so this could have been a worse outcome for sure.

Through HRA (Franklin County Regional Housing Authority) the Town is applying for a Community Development Block Grant (CDBG) to fund the housing rehabilitation program for Leverett. The grant is seeking funds for Leverett, Sunderland, Deerfield, and Conway. Many homeowners in town have taken advantage of this program and we sincerely hope that the grant is successful so the funds for that program can be replenished.

As it happens, this year Town Meeting is competing with the March for Climate Change** that is also taking place on April 29th across the country. I will also be at the march in Washington DC, with my son and his family (farmers in Vermont): We hope people who will be in town that weekend will come to town meeting.

Thanks to everyone who reached out after the death of my husband, Dan Bennett, in December. I was deeply moved by the cards, emails, offers of help and goodwill of all and am truly grateful.

TAX BILLS DUE MAY 1 – HELP OUR SENIORS WITH SOME TAX RELIEF

Many seniors and residents with disabilities in Leverett struggle to pay their taxes and want to be able to continue to make Leverett their home. *The Leverett Tax Relief Committee distributes funds yearly to incomeeligible residents: Seniors 60 and over, as well as qualified individuals with disabilities.* The Committee is now funded exclusively by donations from Leverett residents. *Donations are needed.*

- 1,100 (approximately) tax bills are sent out.
- <u>What if 1,000 Leverett property owners</u> contributed \$5.00 a year? Or more?
- <u>1,000 X \$5.00+ = \$5,000+</u>
- The Tax Relief Committee just awarded over \$5,000 to 11 eligible applicants for 2017.
- Amounts varied between just \$250 to \$750 depending on need. Not much to defray the total bill!

Now we need to replenish the Tax Relief Fund so we can help again next year. YOU CAN HELP!!!

- Help by contributing \$5.00 or more to the Tax Relief Fund. Check the box on the Real Estate bill or your Excise Tax Bill and fill in the amount of your contribution.
- Automatic Deduction: Go online and add your automatic contribution.
- Send a check at any time: Payable to Town of Leverett Tax Relief and get it to our Treasurer/Collector Jason Noschese at Town Hall.

Transfer Station Stuff You Need to Know

New! We now rotate our summer/winter hours with Daylight-savings. This means: Summer hours = March - November. Winter Hours = November – March.

This is different than the rotation in the past; Memorial Day to Labor Day. Why? To accommodate the Wednesday afternoon hours of operation.

Currently we are on summer hours, until November 5, 2017:

Wednesday 4pm to 7pm. Saturday and Sunday 9:30 am to 1pm.

2018 Transfer Station Permits (valid until July 1, 2018) are \$30 and \$3 for additional cars in household. They can be purchased during operating hours at the transfer Station or Tax collector's office. Current 2016 Permits expire on July 1, 2017.

Reminders for responsible spring cleaning disposal:

Remove excess fabric and wood before arriving to transfer station if you would like to dispose them as scrap metal.

Doors must be removed from refrigerators or they will not be accepted.

Remove lids from paint cans. Why: We do not have xray vision. If paint is 100% empty and made of metal, it can be disposed of in the scrap metal dumpster for free. If it still contains any **latex** paint, it must be dried up and disposed of in the construction dumpster for a fee. if it is **oil** paint: keep it at your house until Household Hazardous Waste Day in October. Tip: If the label says you need to clean with mineral spirits; it's oil paint.

All ballasts must be removed from inside the florescent tube lighting before you arrive to the transfer station. The attendant can then properly accept your CFL's and ballasts: **FREE**. We also accept your rechargeable batteries for **free**.

There are so many types of NEW plastic products out there, so it can be confusing, because the standards do change over the years. Here are a few items that are NOT recyclable:

- **BLACK PLASTIC-** Plastic items are sorted by optical scanners which use the reflection of light to identify the types of plastics. Black plastic doesn't reflect light, so cannot be seen and sorted by the scanners and could end up contaminating other materials such as glass bottles.
- **PLASTIC UTENSILS-** These are made of the same resin used to make polystyrene foam and **labeled #6 which is not recyclable**.
- **FREEZER BOXES-** With freezer boxes, it is impossible to remove the plastic from the paperboard, and most municipalities cannot accept this plastic into their recycling stream. **This includes soda/beer boxes.**
- **STYROFOAM-** Styrofoam is made of foamed polystyrene and the technology to recycle this material is not practical, so it has to go in the trash. This also includes items that seem like plastic but they are a combination of Styrofoam and plastic labeled #6
