To one of the Constables of Leverett  
GREETINGS:

In the name of the Commonwealth, you are hereby directed to notify and warn the inhabitants of Leverett, qualified to vote in the Town affairs, to meet in the LEVERETT ELEMENTARY SCHOOL GYMNASIUM at said Leverett, on Monday October 28, 2002 at 7:00 in the evening (7:00 p.m.), then and there to act on the following articles, namely:

ARTICLE 1: To see if the Town will vote to amend the "Code of Leverett" by establishing a Community Preservation Committee consisting of seven (7) voting members pursuant to MGL Chapter 44B §§ 3-7. The composition of the committee, the appointment authority and the term of office for the committee members are designated in a document entitled "Community Preservation Committee Bylaw" on file at the Town Clerk's office. **passed 68-0**

ARTICLE 2: To see if the Town will vote to advise the Select Board regarding the establishment of an early retirement incentive program for eligible municipal employees under the provisions of Chapter 116 of the Acts of 2002, or take any action thereon. **passed**

ARTICLE 3: To see if the Town will vote to raise and appropriate, expend from **Free Cash** or transfer from available funds **\$8,000** to pay for the increased cost of the town's share of health insurance premiums or take any action thereon. **passed**

ARTICLE 4: To see if the Town will vote to raise and appropriate, expend from **Free Cash** or transfer from available funds **\$3,500** to purchase a utility trailer for the Highway Department or take any action thereon. **passed**

ARTICLE 5: To see if the Town will vote to raise and appropriate, expend from **Free Cash** or transfer from available funds **\$10,000** to hire special counsel for personnel, labor and employment law or take any action thereon. **passed**

ARTICLE 6: To see if the Town will vote to raise and appropriate, expend from **Free Cash** or transfer from available funds **\$4,800** to purchase a parcel of land east of the Town Hall containing 37,096 ft and for costs incidental to this purchase or take any action thereon. A plot plan/survey map is available for inspection at the Town Clerk's office. **passed**

ARTICLE 7: To see if the Town will vote to raise and appropriate, expend from **Free Cash** or transfer from available funds a sum of money not to exceed **\$4500** to purchase a photocopier for the Town Hall or take any action thereon. **passed**

ARTICLE 8: To see if the Town will vote to raise and appropriate, expend from **Free Cash** or transfer from available funds **\$7,200** to purchase Assessor's software and hardware or take any action thereon. **passed**

ARTICLE 9: To see if the Town will vote to raise and appropriate, expend from **Free Cash** or transfer from available funds an amount not to exceed \$4,500 for the preparation of a section of the Executive Order 418 Community Development Plan, or take any action thereof. **passed over**

And you are directed to serve this warrant by posting up copies thereof on the post office and in the Town Hall and Congregational Church at Leverett, also the Baptist Church at North Leverett and the Village Co- op at Moores Corner, fourteen days at least before the day of said meeting.
