

The Massachusetts Division of Standards Metrology Laboratory tests and calibrates a range of weights, volumetric, and linear measuring devices for both municipal and private sector agencies. Our calibration services involve comparing the measurement values of weights and measures to calibration standards of known accuracy. All Massachusetts municipalities who conduct weights and measures inspections must have their weights, volumetric and linear measures and instruments tested, adjusted, and certified by the Metrology Laboratory, pursuant to M.G.L. c. 98, Sections 32 and 40.

This proposal is for the restoration of the Howard & Davis scale cabinet of Leverett, Mass.

The item is a very large (66"W x 75"H x 21"D) two-level c. 1848 faux-grained wooden cabinet containing weights and measures that were used by the town's sealer (an elected position) to ensure that the scales employed by Leverett's merchants were accurate (and therefore goods being bought and sold were fairly priced). A cabinet like Leverett's was sent to every town in Massachusetts, by act of the legislature, as part of a mid-19th century effort to establish commercial standards.

It is understood that all weights, measures, scales and other components of the interior will be removed prior to the beginning of this project.

#### Scope of work:

- 1. Clean, repair and touch up the cabinet as needed.
- 2. Two topcoats of finish material, rub out and wax.
- 3. Replace cabinet doors with clear material (see below), allowing the interior elements of the item to be viewed. Remove one or both sets of doors (depending upon where the cabinet is to be displayed).

All work is to be completed on site, in the Leverett Town Hall.

#### Contingencies:

- 1. At the time this project was proposed, the scale cabinet was in the basement of the old library. It appeared to be in excellent physical shape, with minimal damage, mostly caused by age, wear and exposure to temperature and humidity variations. It was agreed that it would be moved to the first floor of the Town Hall, by authority of the town administrator, for restoration and, subsequently, display. Any damage requiring repair that occurs in the course of that move may incur additional cost.
- Subcontractor materials/labor costs were obtained in September 2024, and are included in this proposal with accommodation for year-over-year increases. However, should the materials/labor dramatically increase between the date of the proposal and the date of its approval—expected to be in April 2025—an adjustment to the final cost may be necessary.
