# > Annual Town Meeting and Elections: April 30, 2022

### Election time in Leverett is unlike any other place in the Commonwealth.

Leverett is the only town left in the Commonwealth to elect our public officials from the floor of Town Meeting. How does this work? A few weeks in advance of Town Meeting those who have terms that are expiring take stock of their lives, weigh their happiness, and either decide to run again **or** begin to discuss with friends, neighbors, and family the unequivocal importance of civic involvement. Next, anyone who fell for said speech is nominated from the floor of Town Meeting and their political career is off-and-running. For the Town, this method results in few vacancies, occasional chaos, hysterical bouts of laughter, bursts of applause, standing ovations, memorable quotes and speeches, and the rare election of those not present (physically).

## **Finance Committee**

The Select Board and Finance Committee have been trying hard to provide high-quality services, especially education, to the town while also trying to keep property taxes as low as possible. ## **Board of Assessors**

Hi, my name is Cat Ford. I have been on the Board of Assessors for about twelve years now. I am asking for your support to continue in this position.

When I first started on the Board of Assessors about twelve years ago, I did not know much about assessing, but I took the 40-hour class and I was lucky enough to serve with members who had been on

the Board for over twenty or thirty years each. I learned a lot from them and would like to continue to use those skills.

I feel that I have also had useful knowledge and a unique skillset to contribute to the Board over the years. I have been a carpenter for thirty years, building and remodeling houses in the area. This experience has been helpful during my time on the Board enabling me to explain to the other members things like how houses of different ages are built; what is behind the walls that can't be seen but does add or detract from the value of a home; how much damages or neglect might cost to repair and how much this might deduct from the value of a house; and what percentage of an unfinished house was completed and what that percentage that might represent in actual value.

I also like math, numbers and solving problems. In past years I spent hundreds of hours outside of our regular meeting hours researching high end property values all over the state and working with my fellow board members to defend the town of Leverett against a significant law suit. Currently at the Board of Assessors it has come to our attention that property values, and thus individual property taxes, throughout the United States appear to be disproportionately skewed with higher value properties consistently under-assessed relative to lower value properties. Meaning that lower value properties are carrying more than their fair share of the tax burden for the town where they are located. Since accurately finding "the full and fair cash value" of all properties in our town is our job, the Leverett Board of Assessors has embarked on a project to figure out if this pattern is present in Leverett as well, and if so, what we can do to remedy the situation. I would like to continue working on this project as a member of the Board of Assessors.

#### **School Committee**
